

Alzheimer's Disease Growth




MCHS increases our family intake volume each year to meet the need of rising dementia rates. None of this could be done without the support of the community.

Program Impact

2,845: Number of hours our Program Team spent working one-on-one with families, to help them keep their loved one at home as long as possible.

Improving our Caregiver Skills & Wellbeing

 Families implement 65% of dementia care and resource strategies recommended by MCHS within the first 6 months of service.


 99% of caregivers report that MCHS helped them identify and address priorities and concerns about caregiving.

 98% of caregivers report feeling more confident in their role.

 94% of caregivers report reduced stress as a result of MCHS intervention.

People living with dementia experience 61% fewer trips to the ER, 69% fewer calls to 911, and 67% fewer hospitalizations 3 months after participating in MCHS intervention.

After only 6 months people with dementia experience 59% fewer ER visits, 37% fewer calls to 911, and 83% fewer hospitalizations than before they participated in MCHS intervention.




